**PACKING**

Packing to be in regards to the environmental protection, limiting the use of poly bags as much as possible and should be estimated in accordance w/ the style.

Packing to be in accordance with the Bestseller supplier manual instructions.

Pls pack all styles per box in one poly bag, but each color to be placed in a separate poly bag. The garment should be packed in assortments in accordance with the order.

Packing must ensure the goods to arrive safely.

Each garment has to contain: woven necklabel, size label (unless we use printed main label), care label and hangtag (with Bestseller barcode/price sticker). acc. to description in the supplier manual.

Pls supply all labels + pricestickers from A-TEX at your account. Accessories to be bought through Bestseller HK on your account. All prices must be including label, price sticker and accessories cost.

As per 01.01.2005 the use of PVC in products for bestseller is no longer permitted.

Pls mark each box with Bestseller a/s, item number, item name, order number and assortment size in easily read letters. Each carton must carry shipping marks w/ barcodes on 2 sides of the carton.

It is important that the size of the carton matches exactly with the size of the content. As a minimum standard we require double layered corrugated cardboard. Closing of the carton must be in accordance to the supplier manual. Pls avoid band around the carton and also metal clips.

The maximum weight of each carton must not exceed 20 kg.

It is of high importance that the actual delivered quantity corresponds exactly with the quantity ordered. Should there in certain cases due to unforeseen reasons be any discrepancies, we would as a maximum accept 5% over shipment per. country, standard boxes only.
